Visitors to our website

We do not make any attempt to find out information on who is visiting our website. We do not collect personal information through our website.

The cookies used

Cookies are small electronic files that are placed on your computer when you visit a website. They are often needed to ensure that the website works efficiently.

Please find below a table which explains the cookies that we use and why:

Necessary Cookies

These cookies are essential in order to enable you to log in to the website. Without these cookies you would not be able to log in and use the services of the website.

Performance Cookies

These cookies collect anonymous information on the pages visited. By using the website, you agree that we can place these types of cookies on your device. These cookies collect information about how visitors use our website, for instance, which pages visitors go to most often. These cookies do not collect information that identify a visitor. The information is used to improve the way the website works.

You can opt out of Cookies

You can refuse the use of cookies on this website by refusing to opt into their use by the banner on the home page.

Alternatively you can refuse the use of cookies by activating the setting on your browser which allows you to refuse the setting of cookies. You can also delete cookies by clearing your browsing history (this will depend on your browser).

People who request information on our services
